WHEREAS in May 2014 the KSB issued a public tender seeking garage/workshop space to rent in Kuujjuaq;

WHEREAS one proposal was received from Laval Fortin Adams (9165-2214 Québec Inc.), for building 5023 in Kuujjuaq, for \$120 000.00 for 12 months;

WHEREAS the current lease with Laval Fortin Adams (9165-2214 Québec Inc.), for building 5023 in Kuujjuaq includes the option of a one-year renewal:

WHEREAS the staff of Adult Ed. visited another garage available for rent in Kuujjuaq, however, it doesn't meet their needs.
